Permanency Services

Helping children find emotional healing and forever families. Services also include adoption recruitment activities for Adopt US Kids, and Wendy's Wonderful Kids; a signature program of the Dave Thomas Foundation.

678 children received an array of therapeutic services and their foster and birth families received support and training.

Davidson County Relative Caregiver Program (DCRCP)

Strengthening and empowering relative caregiver families.

666 children and 316 caregivers benefited from counseling and support group, material and financial support, advocacy and family and youth enrichment activities. No children had to enter or re-enter state custody because of the variety of services offered and the responsiveness of the Relative Caregiver Program to potential threats to the stability of the relative caregiver placement.



Community-based Counseling Services

Strengthening families by providing real help for life's hurts and challenges.

Healing the psychological wounds of children exposed to violence.

334 individuals received counseling in accessible community locations to help them reduce symptoms of depression or anxiety, decrease self-destructive behavior or increase self-awareness, overcome domestic violence and/or trauma, and the ability to form and use support networks.

Children who witnessed or were victims of violence received timely therapeutic intervention to help prevent the immediate and long-term negative mental health consequences of traumatic events.

Family Service Counseling

Overcoming Barriers to self-sufficiency.

741 individuals were assessed and received services to help them overcome mental health issues, domestic violence, substance abuse, learning disabilities and child behavior and health issues that would impede their progress toward economic self-sufficiency.

Survivors of Suicide (SOS)

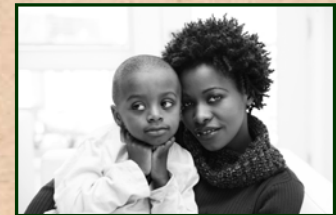
Support groups provided at no cost for anyone who has lost a family member or friend to suicide.

110 individuals attended and benefited from Middle Tennessee's only weekly Survivors of Suicide support groups led by trained facilitators.

The Crisis Center/2-1-1 Help Line

Providing real help for real hurt – right now!

Free, confidential accessible counseling available in 150 languages that assisted: 22,010 callers including 1,204 who expressed suicidal or homicidal ideation. Through 2-1-1 Information & Referral, 169,879 callers received information and/or referral to 1,995 community resources. We now have access to more than 7,000 community resources.



School-based Services

Helping vulnerable children and families thrive.

632 children were served at Cora Howe, Napier and McKissack schools. Families were linked with needed community resources including counseling and children participated in programs focused on Social Skills/Self Esteem, Personal Safety, Conflict Resolution, Academic Self Concept and Decision Making. 97% of students showed improvement in at least 3 of these 5 areas.

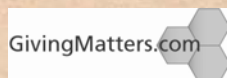
